- Local Government Buildings** e.g. Guildhall
- Local community** e.g. walks
- Other schools** e.g. Ysgol Clywedog, other primary and secondary schools in/around Wrexham
- Local colleges/universities** e.g. Glyndwr University
- Theatres/Cinemas** e.g. Theatre Clwyd, Odeon Cinema, Venue Cymru, Eagles Meadow, Rhyl Pavilion, Stiwt Theatre
- Residential care homes** e.g. Cherry tree Care Home
- Sporting Venues** e.g. Queensway Sports Centre, Wrexham Rugby Club, Colliers Park
- After school Sporting/Eco/School Council** etc events.
- Swimming Pools** e.g. Waterworld, Clywedog
- Visits to places of interest in/around North Wales** e.g. Llangollen, Eisteddfod, Cadburys World Factory, Blists Hill, Telford

I understand that:

- such visits will normally take place within the school/centre normal hours, but that if, occasionally, they are likely to extend beyond this, adequate advance notice will be given so that I may make appropriate arrangements for my child's return home;
- my specific permission will be sought for any visits beyond the types of those listed above or which could involve commitment to extended journeys, times or expense;
- all reasonable care will be taken of my child during the visit;
- my child will be under an obligation to obey all directions given and to observe all rules and regulations governing the visit and will be subject to all normal school/centre discipline procedures during the visit;
- I must inform the school/centre of any medical or psychological condition or physical disabilities that may effect them during the visit;
- all young people are covered by the Local Authority's third party public liability insurance in respect of any claim arising from an accident caused by a defect in the school premises or equipment or attributable to negligence by the Council or one of its employees. Please note that this insurance policy does not include personal accident or personal belongings cover for your child.
